WINTER WATERCRAFT STORAGE

Limited space is available to Stockholders and renters requiring winter storage of their watercraft. Only watercraft registered with the office and displaying a numbered yearly sticker will be permitted.

Watercraft must be registered in the office. Watercraft must have office issued sticker.

Watercraft must be properly covered and winterized.

Watercraft must display name and phone number of owner.

The watercraft must be current with all NYS registering agencies, where applicable.

The Cooperative prohibits any fueling, mechanical work, storage of fuel, gas, oil, or petroleum by-products at the North End. No shrink-wrapping can occur on the Cooperative property without the proper insurance given to the office.

Stockholder/Tenant will assume full responsibility for contamination from any cause of Cooperative property. Storage is at your own risk.

**** The Cooperative assumes no responsibility or liability for loss or damage****

The fee is \$100 per space. Please complete and sign the form - bring it to the office with payment and you will receive a new numbered sticker. (one for boat/one for trailer)

No other boat or trailer is to be moved by anyone other than owner(s) or those given prior permission by owner(s). **Relocation** of anyone else's property is **STRICTLY PROHIBITED WITHOUT PRIOR CONSENT** between owners. **That is why you are asked to make plans and call the boat owner prior to going down to move anything.**

If a contractor is hired to move vessels into and out of the North End and encounters ANY problem with ANY other property in the North End or the Boat Ramp, they must report the problem to the office IMMEDIATELY PRIOR to moving forward with loading or unloading of property.
